

Dear Parents

The following is a letter issued by EA regarding the extension of numbers at Hazelbank PS.

Over the past number of years our applications have generally exceeded our admissions number of 17 and we have had to petition the Department of Education for a variation in numbers to be permitted to admit pupils. This is challenging for the school and creates uncertainty for parents applying.

We welcome this extension to our numbers which will secure the future of the school in the area. The governors support this development proposal which will allow us the flexibility to admit the children in our area without becoming so big as to lose the family ethos of the school.

As with any rural school the number applying each year rises and falls, for example we currently have 16 P2 children and 25 P1 children. We don't envisage filling the 182 places but the admissions number will ease the years when there is a larger number of applicants.

The proposal is now out for public consultation, and you are invited to respond should you wish to do so. The process for comment is outlined for your information.

The Education Authority is currently engaged in the process of area planning and published a Strategic Area Plan 2022-27: Planning for Sustainable Provision in June 2022 and an associated Operational Plan 1: 2022-24 on 1 September 2022. Within Operational Plan 1: 2022-24, Hazelbank Primary School was identified as below:

The Education Authority is proposing to increase the admission and enrolment numbers from 17 to 26 and from 116 to 182 respectively at Hazelbank Primary School with effect from 1 September 2024, or as soon as possible thereafter. This pre-publication consultation will run for a period of 8 weeks, closing on 12 June 2023.
